<p>Background:</p> <p>In 2007, the Umatilla County Special Transportation Coordinated Human Services Public Transportation Plan was first adopted to set out long term vision plans for public transportation within the county to address those serviced through STF funds. The plan is to be periodically reviewed by the STF Committee for needed updates. The plan was updated once in 2014. In 2016, with the assistance of ODOT, proposed changes were made to the plan. As required the proposed plan was reviewed by the STF Committee, and changes were recommended, which were incorporated. WHEREAS Oregon Administrative Rule 732-005-0081 requires each Special Transportation Fund agency to set out the long term vision for public transportation in the STF Agency's service area, and to guide the investment of STF monies to maximize benefit to the Elderly and People with Disabilities within the area;

WHEREAS the Board of Commissioners of Umatilla County serves as the Special Transportation Fund Agency for Umatilla County;

WHEREAS on June 12, 2007, a Special Transportation Coordinated Human Services Public Transportation Plan was adopted for Umatilla County by the Board of Commissioners by Order No. BCC2007-82, and updated on January 22, 2014 by Order No. BCC2014-04;

WHEREAS a STF Agency is to review its plan periodically, and update it to reflect changes in the service area, demographics, funding levels, service availability or other factors, as needed;

WHEREAS OAR 732-005-0081 further provides that prior to adopting a STF Plan, the STF Agency is to consult with the STF Advisory Committee and the public to ensure that the Elderly and People with Disabilities, representatives of the Elderly and People with Disabilities, transportation Providers, and other interested parties have the opportunity to review and comment on the proposed plan;

WHEREAS in 2016, Umatilla County and the Oregon Department of Transportation decided to update the county's Coordinated Human Services Public Transportation Plan (the Coordinated Plan) to address a combination of regulatory and community goals;

WHEREAS a copy of the revised plan drafted by Nelson/Nygaard Consulting Associates was provided to the Umatilla County Special Transportation Committee for review, and the committee recommended changes, which have been included in the proposed updated plan.

NOW THEREFORE the Board of Commissioners orders that amendments to the Umatilla County Special Transportation Coordinated Human Services Public Transportation Plan, adopted June 12, 2007 and amended January 22, 2014, are approved and the amended plan, as set out in the August 2016 copy attached to this order and incorporated by this reference, is approved and adopted for the area served by Umatilla County.
