WHEREAS the Board of Commissioners has ordained Ordinance No. 94-20, adopting a comprehensive fee ordinance for county services performed for the public;

WHEREAS ORS 203.115 permits the county governing body to set fees charged for county services and to amend the fees enacted;

WHEREAS ORS 454.745 authorizes the county to set fees for services for regulation of subsurface sewage disposal;

WHEREAS the Umatilla County Board of Commissioners desires to inform the public of all fees charged for County services.

NOW, THEREFORE the Board of Commissioners of Umatilla County ordains that the Comprehensive Fee Ordinance, No. 94-20, dated November 7, 1994, shall be further amended as follow (deleted words are ~~struck through~~ and added words are *italicized and underlined*):

§ 39.410 ALCOHOL & DRUG TREATMENT.

§ 39.411 SLIDING FEE SCHEDULE.

(A) The Umatilla County Alcohol and Drug Treatment Program establishes an hourly "clinic cost" of service for all service types.

(B) This schedule is based on the client's gross household income and size (number of individuals contributing to and/or dependent upon the household income) and identifies the "least rate" payable. The rate established will be the hourly fee charged for services. The Program established a reasonable and customary cost to provide service and third party payers are billed this rate. Applications for exceptions are available from program staff. Exceptions must be supported

by documentation and approved by the Department Program Manager.

- (C) No client will be denied service based on inability to pay.
- (D) Clients are charged per hour of service delivery time.
- (E) Rate schedule.
