SUBJECT: UTV Purchase

<p>Background: The County previously issued a request for proposals for the purchase of a utility task vehicle for Emergency Management. The proposal received was higher than the grant for the purchase. Upon review of the possible options, it is requested that a purchase utilizing the SourceWell contract will be the most cost-effective option moving forward. This will require a scale back on the original project concept and move some items to "Phase 2" and go after additional grant funding for those items. We will however be able to purchase the Polaris UTV as well as a trailer to use for deployment with these funds. The total grant award is for \$48,838.00 of which \$45,932.83 will be used to acquire the Polaris. The remaining grant funds will be used to locally purchase the trailer and any funds remaining after that will be used to buy supporting equipment as outlined in the grant.</p>	<p>Requested Action: Authorize purchase of Polaris from Polaris Sales in the amount of \$45,932.83</p>
