 - 6) MUST WEAR LONG PANTS, AND WESTERN BOOTS
- PARK YOUR RIG WITH CONSIDERATION, SO ALL PEOPLE AND HORSES ARE SAFE
ABSOLUTELY NO PARKING ON THE GRASS WITH SPRINKLERS
