Notice is hereby given on February 26, 2024, the Umatilla County Board of Commissioners filed a ballot title for the May 21, 2024 Primary election ballot with Umatilla County Elections Division.

The following shall be the ballot title:

**Caption:** Increases Minimum Age of Sheriff in Umatilla County Charter

**Question:** Shall the age requirement for Sheriff be increased from 21 to 25 years of age in the Umatilla County Charter?

**Summary:** If adopted, this proposal amends the Umatilla County Charter to require the Umatilla County Sheriff be at least 25 years of age to be a candidate for the office.

The language in the Charter would be amended to read: Any candidate for office of sheriff shall present to the county elections officer a written certification from the Oregon Board of Public Safety Standards and Training showing that the candidate meets the qualifications, is a citizen of the United States of America, and is at least 25 years of age.

As indicated in ORS 250.195, an elector may file a petition for review of ballot title in Umatilla County Circuit Court no later than 5:00 p.m. March 12, 2024.
