had 5. Black and white wire we have 0.7Volts. Spec is 0.5 to 1.5Volts. Left side hopper found transducer was bad. Could not get volts out of it. Kept throwing transducer code. Ordered new part.

Got new transducer from parts and replaced left side trandsducer with the new one. Set up the transducer angle according to the manual. Found that the gates would open fully but not return to fully closed even though the voltages were in specification. adjusted the transducer read the correct voltages and the machine operated correctly until we test drove and found the variable hopper on the right wouldn't adjust with speed changes and the left barely would. The computer according to the voltages thinks the gates are fully closed when they are in fact 1/4 inch open. We adjusted the adjusting screws down so the gate position matches what the computer is commanding. Testing this it worked once we programmed the null and scale settings. Moving to the right hopper we tried adjusting the right transducer according to spec and then adjusting the screws like we did on the left side. The gate position was too far out of adjustment in the closed position to use the adjusting screws. We then tried programming the null and scale settings. The null setting would adjust to 0.00 like it should. However the scale setting would read 1.63 inches at fully open and the override to make it read 4 inches wouldn't work. The next step is to call and find out why the scale function won't operate like it should.
