1. Local Assistance Fund Grant. Presented by Comm Murdock. In 2020 there were issues with the City of Weston sewer system. He spoke to Mayor Thul regarding the project. The City is requesting the funds based on estimates and if the cost is below what they are anticipating, they will return unexpended funds to the county – similar to Echo project. Authorization is sought for a grant from the Local Assistance and Tribal Consistency Fund as part of the American Rescue Plan. The grant would be for emergency sewer upgrades for the City of Weston. The amount requested is \$90,000. **Commissioner Murdock moved to approve the grant payment as outlined. Seconded by Commissioner Dorrان. Carried, 3-0.**

We received one last year, and we will now need another one to get us through this project. Anderson & Perry could not secure permits for this year for the project, however, they believe we should be on target to have them for 2025, and that we should have a completion date no later than December 31st, 2025.
