- Notes**
- 1 - On-call NP or head nurse will take call round the clock
 - 2 - Per Diem over \$.2.25 If sustained ADP over 210, although the parties will meet to determine whether additional staffing is needed once DAP is 200
 - 3 - NP hours These hours may be provided onsite, via telemedicine or over the phone
 - 4 - Dental Included go to Cap
 - 5 - EMR If requested by County there is an approximate (100% passthru, no mark-up) \$25,000 one time fee (includes 2 interfaces) plus \$300 per month for less (rates are subject to change) than 150 ADP (over 150 ADP \$2 PIPM) plus \$5000 for any additional interface needing built. This is not built into the Year One Price.
 - 6 - Terms of service
 - a Insurance limits we provide are 1 mil/3 mil, we have requested our carrier offer 2 mil/4 mil
 - b All supplies, labs, x-ray, EMS, pharmacy, offsite and onsite specialty care go to Cap
 - c All supplies, office and medical equipment and bio waste will be provided by County or included in the Cap, as the County directs
 - d MedHealth will monitor offsite hospitalization and review claims to ensure accuracy
 - e Either party may terminate the resulting contract for inmate health services without casue by providing no less than 180 days written notice to the other party
 - Annual Cap MedHealth will pay up to \$125,000 for each 12 month contract period (pro rated for other periods) for items listed as going to the Cap. MedHealth pays 100% of staffing and insurances (PLI, GL, WC) costs.
 - 7 - Staff Exchange Higher credential staff may be substituted for lower credentialed staff (e.g., an RN for LPN)
 - 8 - Payment MedHealth will invoice Umatilla County prior to the start of each month and County pays us within 30 days of invoice receipt
