WHEREAS on February 5, 2004, Athena-Weston Education and Resource Enhancement (AWERE) was formed by the Board of Commissioners;

WHEREAS AWERE was established to distribute private charitable donations from FPL Energy to community improvements projects within AWERE's Service Area, specifically the annual donation of \$75,000 that begins in 2012, and which will continue to 2021, and also funds from Community Services Fees under the Oregon Strategic Investment Program, with a current balance available for awarding of approximately \$180,000;

WHEREAS the AWERE Board reviews grant requests for the funds and makes a recommendation to the Board of Commissioners for review and approval;

WHEREAS the AWERE Board has made recommendations for recipients of the 2022 grants for the funds received in December, 2021, for a total of \$180,000.

NOW THEREFORE, the Board of Commissioners orders as follows:

- A. The following distribution of AWERE funds is approved:
 - 1. City of Weston Park Kitchen \$15,819
 - Umatilla County Emergency Hazard Preparedness -\$10,369.50
 - 3. Caledonian Games Electrical/Water \$2,780
 - East Umatilla County Ambulance Fire/Rescue ATV -\$19,819
 - 5. Umatilla County Pioneer Association Pioneer Days - \$5,000
 - 6. Kees Blue Mountain Cemetery Fence Repair \$2,965

- 7. East Umatilla Fire & Rescue District ATV and Software - \$19,819
- 8. Weston Middle School Playground Court \$39,244
- 9. Athena Elementary School Track Shade Structures \$46,365.50
- 10. Weston McEwen High School LED Lighting Upgrade - \$17,819

Each project and improvements are to be completed by December 31, 2022. Each recipient shall execute acknowledgment for awarded funds. Funds will be distributed on reimbursement basis to recipients upon request and verification by recipient.
