Weddings and events are not farm uses. Thus, they should instead be permitted under 215.283(2) (*nonfarm uses*). These Type 2 uses are subject to a conditional use permit (in Umatilla County) and are required to demonstrate that the use will not: (a) force a significant change in accepted farm or forest practices on surrounding lands devoted to farm or forest use; or (b) significantly increase the cost of accepted farm or forest practices on surrounding lands devoted to farm or forest use.

In addition to the above requirements located in ORS 215.296, the county may impose additional requirements on Type 2 uses. Examples of these requirements could be: requiring adequate parking, requiring onsite septic authorization, evaluating traffic impacts on adjacent County and private roads, annual reviews, recording a Covenant Not to Sue (protects farmers from lawsuits regarding accepted farming practices), and limiting the number and frequency of events. Typically, weddings and other events are held every weekend during the summer months. As a Type 1 use, this could not be limited during harvest season, nor could impacts to nearby residents be mitigated. Farmers and residents would not have a voice or recourse should wedding and events be allowed outright. Umatilla County Community Development staff support HB 2487, with the amendment of the use being permitted as Type 2 use, not permitted as a Type 1 use. This amendment will provide a voice and additional protections to adjacent and nearby farmers and residents, and gives the County the authority to impose additional requirements and limitations.

The amended text would be under ORS 215.238(2): (ee) In areas lying east of the summit of the Cascade Range and in counties with a population of fewer than 85,000, a wedding or event venue that is conducted outdoors or in farm buildings and that complies with any limitations imposed by the county.

On behalf of the Umatilla County Board of Commissioners, please accept this letter of support for House Bill (HB) 2487. HB 2487, as currently written, would allow a wedding or event venue that is conducted outdoors or in farm buildings in areas lying east of the summit of the Cascade Range and in counties with a population of fewer than 85,000. Umatilla County supports the intent of HB 2487, but recommends an amendment to the bill so the proposed use is allowed under ORS 215.283(2) (non-farm uses), rather than being allowed under ORS 215.283 (1) (outright uses). This change would give eligible counties the discretion to apply conditions that minimize impacts to surrounding farm uses while still supporting the county's growing agritourism industry.
