for a County Opportunity Grant)

WHEREAS the Oregon Parks and Recreation Department is accepting applications for the County Opportunity Grant;

WHEREAS Umatilla County desires to participate in this grant program to the greatest extent possible as a means of providing needed park and recreation acquisitions, improvements and enhancements;

WHEREAS the Umatilla County Commissioners have identified the construction of a new County RV Park as a high priority community desire and need in the County;

WHEREAS Umatilla County proposes to construct a new RV Park facility for those needing recreational lodging. It will be located in the Southwest Quarter of the Southeast Quarter of Section 13, Township 4 North, Range 28 East, Willamette Meridian, Umatilla County, Oregon; said Tract being more particularly described as follows: The South 593' of the East Half of the Southwest Quarter of the Southeast Quarter of Section 13, Township 4 North, Range 28, East of the Willamette Meridian, Umatilla County, Oregon. The county is working with Anderson Perry Engineers to develop a safe, ADA accessible, and sustainable facility that is adequately shaded for safe use in a climate with consistently moderate to high summer temperatures

WHEREAS Umatilla County has available local matching funds to fulfill its share of obligation related to this grant application should the grant funds be awarded;

WHEREAS Umatilla County will provide adequate funding for on-going operations and maintenance of this park and recreation facility should the grant funds be awarded.

NOW THEREFORE the Board of Commissioners orders as follows:

1. It is in support for and authorizes the submittal of a grant application to the Oregon Parks and Recreation Department for a Umatilla County RV Park.

2. Authorizes the Chair to sign grant application, grant agreement and documents to such requests.

3. This order is effective following its adoption by the Umatilla County Board of Commissioners.
