We are switching up the radio stations, these new ones provide good direct coverage for most of Umatilla County (Hermiston, Stanfield, Milton-Freewater, Umatilla). This year we are also expanding into some TV ads on Spanish language stations for providing public health related messaging in that area. This is a reduction in overall contract price from previous years; this was at our request due to tightening budget outlooks. All funding for this contract would come from Program Element funding provided by OHA, with the main bulk coming from our PE51-01which is our Modernization funding.
