WHEREAS the Board of Commissioners has adopted a Comprehensive Plan for Umatilla County;

WHEREAS an application was received from Jeff and Michelle Hines requesting Umatilla County to amend the Comprehensive Plan to add approximately 67 acre site located in Sections 28 and 29, Township 3 North, Range 29, to the Goal 5 protected significant aggregate sites, #T-098-24;

WHEREAS the Umatilla County Planning Commission held a public hearing on October 23, 2025 to review the application and the proposed amendments and recommended that the Board of Commissioners approve the application to add the quarry to the Umatilla County resource inventory;

WHEREAS the Board of Commissions held a public hearing on December 10, 2025, to consider the proposed amendments, and voted for the approval of the application and the amendment.

NOW, THEREFORE the Board of Commissioners of Umatilla County ordains that the Umatilla County Comprehensive Plan, adopted May 9, 1983, be further amended to add the following property to the existing aggregate site identified as the Muleshoe (Snow) Quarry to the Goal 5 Aggregate Resources/Rock Material Sources Inventory as a Significant Site, private, commercial pit, located on Umatilla County Tax Lot 3N29-12800 consisting of approximately 67 acres, of a portion of West Half of West Half of Section 28, and Southeast Quarter of Northeast Quarter and North Half of Southeast Quarter, Section 29, Township 3 North, Range 29, East of Willamette Meridian, Umatilla County, Oregon, and apply the Aggregate Resource (AR) Overly Zone to the entire quarry site. A map depicting the site is attached as Exhibit A, and incorporated by this reference. The approved post-mining use is farming and ranching.


