I, W.E.O. Criger, being first duly sworn, on oath say: that I have correctly surveyed and platted the land as represented by the accompanying plat of Daines Addition to the City of Milton, Oregon; the exterior boundaries of which are described as follows: From a point where the South line of Martin Street intersects the easterly line of Grover Street as shown on the duly recorded plat of Ireland's Addition to Milton, Oregon; thence Northwesterly on the east line of Grover Street 302.76, thence Northeasterly on the center line of Martin Street, extended, 547.1 feet, to the point of beginning; at which point I planted a two inch iron pipe three feet long, the top thereof being driven six inches below the surface of the ground, in accordance with sec. 19-1304, Oregon Code, annotated; thence northeasterly on the extended center line of Martin Street 124.2 feet, to the present center of the Walla Walla river; thence southeasterly 312.5 feet, to a point 719.2 feet from, and at Right angles to, the easterly line of Grover Street; and 308.75 feet from, and at Right angles to the extended Center Line of Martin Street; thence southwesterly and parallel with the center line of Martin Street, extended, 124.2 feet; thence northwesterly 312.5 feet in a straight line to the point of beginning. Excepting all water rights of way and underground pipe lines.

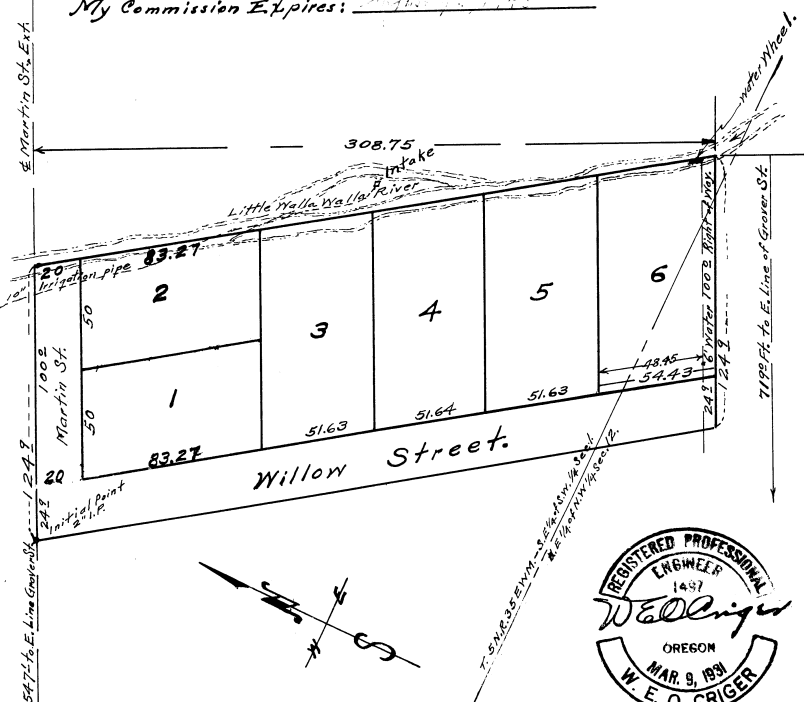
