



ENGINEER'S CERTIFICATE:

I Stanley G. Wallulis being first duly sworn, depose and say, that I am a duly registered engineer of the State of Oregon, that I have correctly surveyed and marked with legal monuments the land represented on the attached plat of: REPLAT OF BLOCK 6, WEST HILLS ADDITION TO THE CITY OF PENDLETON, OREGON; at the initial point of said survey I set a concrete monument six inches by six inches by twenty four inches, six inches below the surface of the ground and located S84°35'20" E a distance of 1681.62 feet from the NW corner of the SW quarter of Section 3, T. 2 N., R. 32 E. W.M., Umatilla County, Oregon, the property is described as follows: Beginning at the described initial point, thence S89°29'50" W a distance of 190.63 feet, thence S 0°49'30" E a distance of 148.80 feet, thence westerly along the arc of a curve to the left whose radius is 224.18 a distance of 240.17 feet, thence S 62° 12' 30" E a distance of 281.66 feet; thence easterly along the arc of a curve to the left whose radius is 30.00 feet a distance of 55.22 feet; thence northerly along the arc of a curve to the right whose radius is 1131.12 feet a distance of 143.43 feet; thence N19° 35' 30" E a distance of 127.78 feet; thence N 74° 52' 30" W a distance of 36.56 feet; thence westerly along the arc of a curve to the right whose radius is 628.35 feet a distance of 260.64 feet; thence N51° 06' 30" W a distance of 45.49 feet; thence westerly along the arc of a curve to the left whose radius is 227.22 feet a distance of 190.63 feet to the point of beginning.
