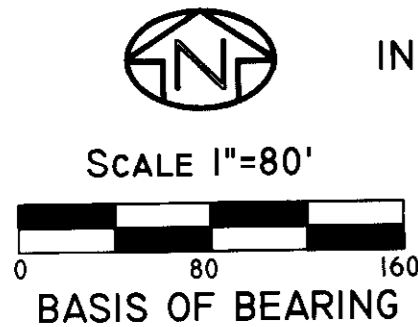


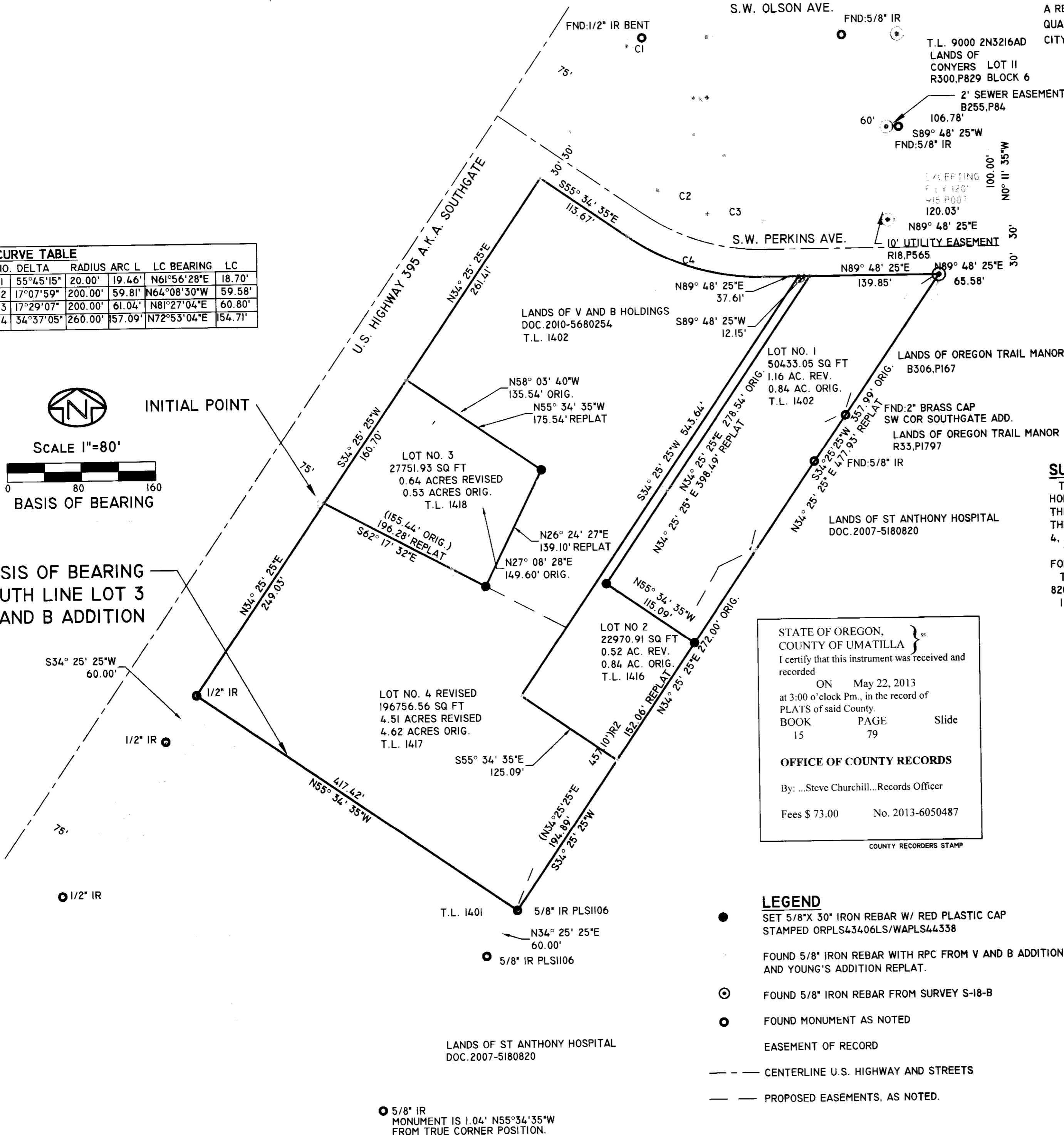

THIS SURVEY WAS PERFORMED AT THE REQUEST OF TOM KENNEDY, OWNER, OF V AND B HOLDINGS, LLC., TO PERFORM A REPLAT OF LOTS 1 THRU 4, OF THE V AND B ADDITION. THESE REVISIONS WERE MADE TO GIVE THE PROPER SET-BACK ALONG THE SOUTH SIDE OF THE NEW INTERPATH BUILDING, AND FOR CONSTRUCTION OF A NEW BUILDING ON LOT 4, AND RECONFIGURE LOTS 1 AND 2 FOR PLANNED CONSTRUCTION. THE SOUTH LINE OF LOT NO. 3 OF V AND B ADDITION WAS HELD AS BASIS OF BEARING FOR THIS SURVEY. THIS SURVEY WAS PERFORMED USING A SOKKIA GSR 2700IS RTK GPS SYSTEM, A TOPCON 8203B ROBOTIC TOTAL STATION, AND A SOKKIA SET 500 TOTAL STATION. I FIND NOTHING OUT OF THE ORDINARY ON THIS SURVEY.

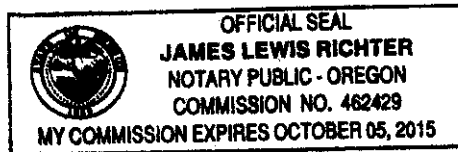
