I commence at the SE corner of the NE $\frac{1}{4}$  of Sec. 27, T 6 N R 32 E W M. At a point N 20 ft. and E 20 ft. from aforesaid point I set a post, 4 ft long 4 ins. square, marked R 736; dug pits, 18 x 18 x 12 ins. E & W of post, and raised mound of earth, 18 ins. high 4 ft. base around post.
