TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY

We, the undersigned board of County Road Viewers, heretofore instructed to view, survey, and vacate said road, submit the following report:

Pursuant to an order of the Honorable County Court, we met at point of beginning of said road on the 25th day of April, 1917. We called to our aid L.C. Rothrock, Chairman, W.J. Stockman, Flagman, Willard Bradley, Marker, who were by the Surveyor each duly sworn. We viewed, surveyed and vacated said road as specified in our order. We find said route of little use to the general public of the County, and the County Court will not be justified in maintaining the same. We therefore recommend that the County Court declare this road vacated, and no longer a County Highway.

NOTES OF SURVEY TO VACATE COUNTY ROAD
PETITIONED FOR BY MARTIN KUPERS, ET AL .

TO THE HONORABLE COUNTY COURT UMATILLA COUNTY, OREGON:

I submit the following as the notes of the survey to vacate a county road as petitioned for by Martin Kupers, et al.

Began at a point 20 ft. west of the corner of Sections 15, 16, 21, 22 T 3 N, R 33 EWM Ran thence west bet. sections 16 and 21 60.00 chains, road leaves section line and turns north, 65.00 chains north 2.80 chains to center line of road, 69.50 chains ravine course south, 7.00 chains north to road and two bridges over ravine, 72.00 chains road again touches section line, 79.75 chains cor. sections 16, 17, 20, 21., 120.00 chains intersect east line of county road running north and south through center of Sections 17-20.

In the matter of viewing County Road proposed to be vacated commencing at the intersection of Despain Gulch Road, in sections 3 and 4, T. 3 N., R. 31, E. W. M.

To the Honorable County Court of the State of Oregon, for Umatilla County.

We, the undersigned Board of County Road Viewers, heretofore instructed to view said road, beg to submit the following report.

Pursuant to your order we met at Pendleton, Oregon on the First day of April 1918. The viewers each having been duly qualified we viewed said road as specified in our order.

We find that the said road has been open to traffic but is very little used at present, that if it is laid out on a route having very steep grades, that on account of its situation and location will never be needed as a part of the general road system and as a local road it is not needed at the present time.

We therefore recommend that the aforesaid road be vacated.
