Now on this day comes the report of A. Hopson, R. M. Dorothy & Geo. Dehaven the viewers heretofore appointed at the May Term 1889 of this Court to view & determine how much less valuable the lands of O. R. Ballou, Francis Hault & W. J. Chastain would be rendered by reason of the location of the above mentioned road as a County Road for final hearing, the same having been read on a previous day of this term of this Court to wit May Term 1889 & it appearing from said report that said viewers duly met at the time & place appointed & were duly qualified before entering upon the discharge of their duties in this behalf, & it further appearing from said report that the said viewers have estimated & appraised the damages sustained to the land of O. R. Ballou at \$100⁰⁰ Francis Hault \$50⁰⁰ & W. J. Chastain \$100⁰⁰

And it also appearing to the Court that the viewers heretofore appointed to view out & report upon the location of the above mentioned road duly made their report at the Term 1889 of this Court, & that said viewers reported favorably & recommended the location of the same as a County Road, & the field notes & plat of survey of said road being duly on file & certified to by the Surveyor appointed to survey the same.

It is therefore ordered by the Court that the report of said viewers be accepted, & that the road be established in accordance with said report
