

To the Honorable, the County Court of the

The undersigned your Petitioner, House-  
holder of the County of Umatilla, State of  
Oregon and Residing in the vicinity of the  
proposed Road herein after mentioned  
and described. Most Respectfully

locate a County Road forty feet wide  
as follows to wit:

Beginning at the South west  
corner of Section six (6) in Town-  
ship five (5) North of Range 36  
East Willamette meridian. Running  
thence east on a section line one  
mile to the South east corner of  
said Section six. Thence north  
on a section line between section  
five and six one half mile to  
a quarter section corner or post.

Thence due east to intersection of  
a County road running northerly  
from George Deboer's ~~farm~~ to its  
State line. Known as the Deboer  
Road. Thence northerly along said  
Road to the Township line between  
Township five and six N of Range  
36 East W.M. Thence due east  
on the Township line two miles and  
a quarter of a mile to the north  
east corner of Section three in
