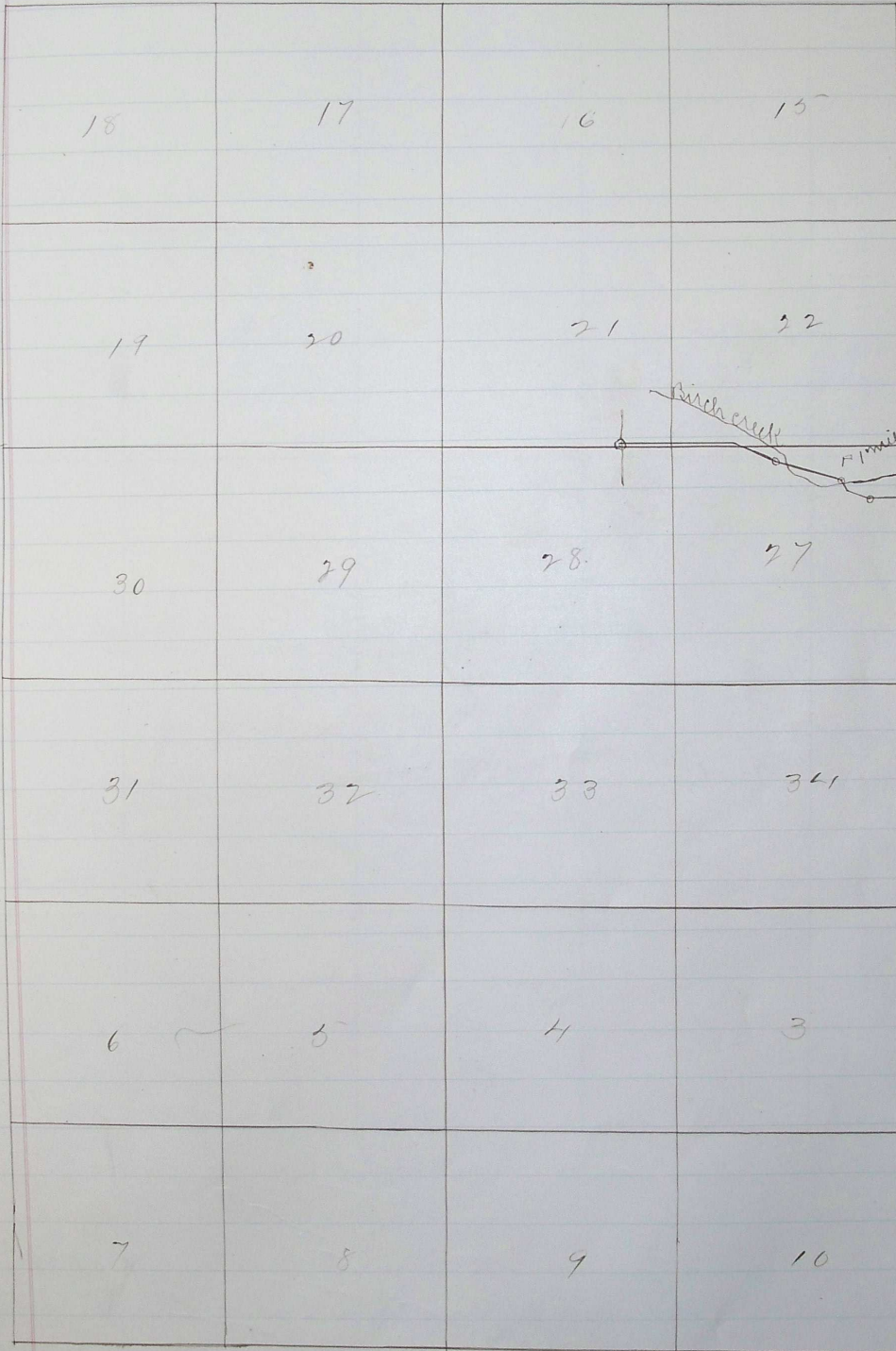

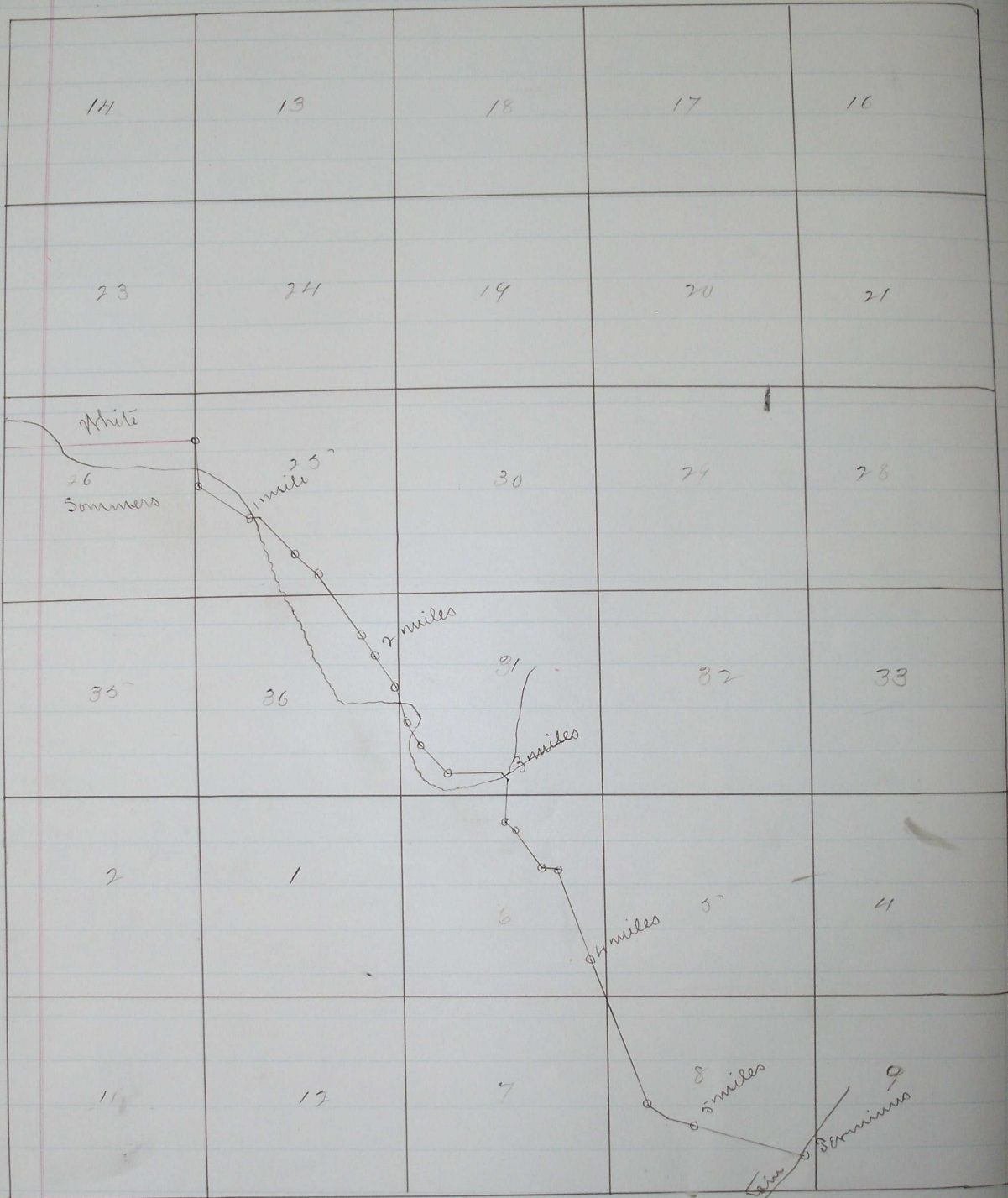
Plat of Road commencing at the S.W. corner of the E 1/2 of the S.E. 1/4 of Sec. 21 Town & R 36 E and running to White Lane
