Beginning at a point approximately 980.0 feet north of the center line of, and on the east boundary of section 7, Twp 4 North, Range 37, E.W.M. which is the point of beginning:- Thence proceed around a spiral curve left with a long chord bearing south 64° 22' east for a distance of 224.0 feet; thence along a tangent bearing south 68° 34' east for a distance of 1.3 feet; thence around a spiral curve right with a long chord bearing south 64° 58' east for a distance of 240.0 feet; thence around a 6° curve right for a distance of 61.4 feet; thence around a spiral curve right with a long chord bearing south 54° 05' east for a distance of 240.0 feet; thence along a tangent bearing south 50° 29' east for a distance of 88.6 feet; to and which is the end of the project and containing 1.18 acres more or less.~~
