

ROAD NOTICE.

Notice is hereby given that the undersigned freeholders residing in Umatilla County, Oregon, and in Road District No.3 where the hereinafter described proposed road is to be located, will present a petition to the Honorable County Court at its regular term to be held in the Court House in the City of Pendleton, in said County and State, on Wednesday the 5th. day of April 1911, for the laying out and establishing a County Road as follows, to-wit:

Beginning at a point where Cherry Street in Nichols' Second Addition to Milton, Umatilla County, Oregon, crosses the South boundary line of Milton City; running thence Southeasterly along the line of Cherry Street as shown on the duly recorded plat of said Nichols' Second Addition to Milton, to the Westerly bank of the Walla Walla River; thence Southerly along the West bank of the Walla Walla River 100 rods more or less to the mouth of Couse Creek; thence nearly South along the East bank of Couse Creek about 200 rods to the center of the Northwest Quarter of the Northwest Quarter of Section 19, Township 5 North of Range 36 E.W.M.; thence Southeasterly along the gulch to intersect the present County Road at a point 250 feet East of the Northwest corner of the Southwest Quarter of the Southwest Quarter of Section 33, Township 5 North, Range 36 E.W.M., said present County Road leading to Lincton Mountain, said road to be forty feet wide.
