Umatilla County, State of Oregon, to-wit: A strip of land 60' wide for highway purposes

over and across the SW 1/4 of Sec. 35 Twp. 5 N.R. 36 EWM., more particularly

described as beginning on the Twp. line 1600' East of the SW corner to

Sec. 35 Twp. 5 N. R. 36 EWM thence around a 4° curve to the left, the

long cord of which bears N 78° 39' W. a distance of 302.7 feet thence

N 84° 42' W. a distance of 316.6 feet thence around a 9° curve to the

right the long cord of which bears N. 64° 12' W. a distance of 455.5 feet

thence N. 43° 42' W. a distance of 844.4 feet to the East line of Sec.

35 Twp. 5 N.R. 36 EWM, said point being N. 905 feet more or less of the

SW corner to sec. 35 Twp. 5 N.R. 36 EWM and containing 2.6 acres more

or less.
