to them paid, have bargained and sold and by these presents do bargain, sell and convey unto Umatilla county, Oregon

the following described premises, to-wit: ... lying and being in the N.W. 1/4 of the N.W. 1/4 of section 4, T. 5, N.R. 35, E.W.M. Umatilla county, Oregon, and described as a piece of land 40 ft. wide lying on the N.W. side of that strip of land deeded by the grantors herein to the O.W.R.&N.R.R.Co. and being contiguous and lying parallel therewith to said strip of land deeded to said company; the N.E. Corner of said described land herein granted is in the township line common to 5 and 6 N.R. 35, E.W.M. Umatilla county, Oregon, and being 18 1/2 rods more or less east from the section corner common to sections 4 and 5 in township 5 and sections 32 and 33 in township 6, N.R. 35, E.W.M. Umatilla county, Oregon; thence from said described point southwest along the O.W.R.&N.R.R.Co. property to the point of intersection with the county road a distance of 36 rods more or less thence north along said county road a distance of 80 feet more or less to a point which is at a perpendicular distance of 40 feet from the O.W.R.&N.R.R.Co.'s property thence north east parallel with and at a distance of 40 feet from the O.W.R.&N.R.R.Co property to the point of intersection of said line with the township line which is common to 5 and 6 N.R. 35, E.W.M. 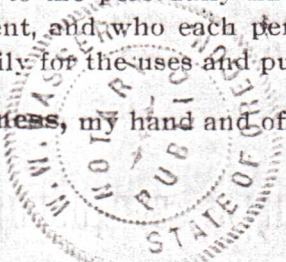
