Known as the Weston Mountain Highway

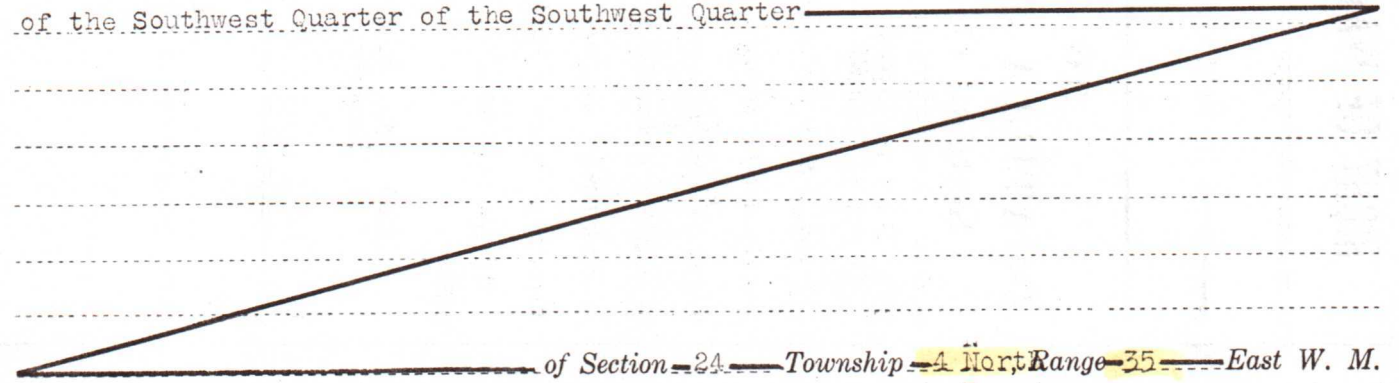
Know all men by these presents, That Nora M. Watts and F. D. Watts, her husband and Grace Rogers and E.C. Rogers, her husband,

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across a portion of the Southwest Quarter of the Southwest Quarter

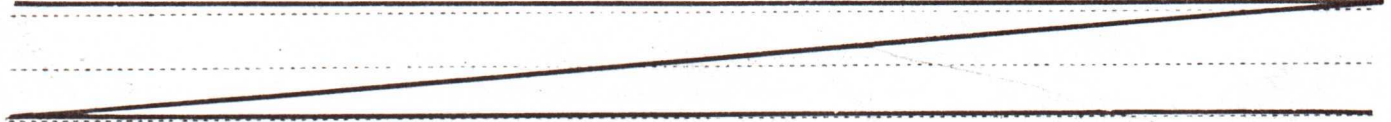


of Section 24 Township 4 North Range 35 East W. M. Beginning at Station 92 + 30 of the Weston Mountain Highway Survey

which Station is approximately 20 feet West and feet of the Sixteenth Corner in center of Southwest Quarter Section 24, Township 4 North, Range 35 East W. M. Thence on a 30 curve to the right whose tangent at that point bears Southwesterly a distance of 320 feet. Thence running in a Northwesterly direction approximately 11 feet to Station 95 + 61 of

the said survey, which Station is approximately 296 feet West and feet of the Sixteenth corner in center of Southwest Quarter of Section 24, Township 4 North, Range 35 East W. M. Containing 0.46 acres more or less. Range East W. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
