has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across the Northeast Quarter of the Northeast Quarter

of Section 26 Township 4 North Range 35 East W. M. Beginning at Station 146 / 79 of the Weston Mountain Highway Survey which Station is approximately 1235 feet South and 340 feet West of the Section Corner which is common to Sections 23, 24, 25 and 26 Township 4 North Range 35 East W. M. Thence running in a Northwesterly direction approximately 736 feet to Station 154 / 15 of the said survey, which Station is approximately 660 feet South and 458 feet West of the Section corner which is common to Sections 23, 24, 25 and 26 Township 4 North Range 35 East W. M. Contains 0.88 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
