ORDER FIXING DATE
FOR HEARING ON REPORT
OF COUNTY ROADMASTER.

This matter coming on now upon the Resolution of the Umatilla County Court dated April 27, 1955, for the vacation of a portion of County Road 27 in Section 23 and 24, Township 4 North, Range 35 East of the Willamette Meridian in Umatilla County, Oregon and

It further appearing that the proceedings to vacate said road were undertaken and the County Roadmaster directed to examine said road and make a report in writing on the same and to file said report with the County Clerk of this County, and

It further appearing that the County Roadmaster has examined the road and made and filed his report in writing with the County Clerk, and that this Court should now fix a date for hearing upon said report and cause notice of the hearing to be given by advertisement posted at the place of holding County Court and at three public places in the vicinity of the road, at least thirty days before the date set for hearing, and the Court being fully advised in the premises,

It is hereby ordered that the 8th day of June, 1955, at the hour of 10:00 o'clock A.M. of said day, at the Court Room, Temporary Umatilla County Courthouse, City of Pendleton, Umatilla County, Oregon, be, and the same is hereby, fixed and designated as the date, time and place for a hearing on the report of the County Roadmaster pertaining to the vacation of the portion of County Road 27 above described, and

It is further Ordered that notice of said public hearing shall be given by advertisement posted at the place of holding County Court

and at three public places in the vicinity of the road to be vacated,
at least thirty days before the date set for hearing, said Notice
to be posted by the County Roadmaster or his duly authorized assistants.
