Whereas, the Umatilla County Court and Umatilla County Road Department no longer considers the above described portion of said County Road #27 to be a useful part of the Umatilla County Road Department roads network or to the general public, and

Whereas, the public will be benefited if the portion of said County Road #27 is vacated because said portion of road is dangerous and burdensome to maintain,

Now, Therefore, Be It Resolved, that proceedings to vacate said portions of said County Road #27 be undertaken, and that the Umatilla County Roadmaster is hereby ordered to examine said road and make a report in writing on the same, and said written report is to be filed in the office of the County Clerk of Umatilla County, State of Oregon.
