

To the Honorable County Court of the State of Oregon, for Umatilla  
County:

We, the undersigned your petitioners, who are residents and householders in Umatilla County, Oregon, and who reside in the vicinity of the hereinafter described route for a County road, respectfully petition your honorable body to cause to be laid out, located, and established, a County road in said County and State, commencing, running and terminating as follows, to-wit:

Commencing At a point of the County road in Township 3 North of Range 36 East N. M. at or about the center of the North East  $\frac{1}{4}$  of Section 5. Thence running south on said center line to the brakes of Wild Horse Creek, Thence East up the brakes along said creek for about 40 Rods, thence down said creek for about 20 Rods crossing said creek below a certain watering place in the said creek, Thence up the creek on south side, on the most practical route till it strikes a certain Canyon Thence south up said Canyon to Mr. A. Tidhunter's Residence, Thence south East to section line between sections 8 and 9. Thence south on said line to the south prong Wild Horse Creek, Thence down the brakes of said creek for about  $\frac{1}{4}$  mile, Thence West about  $\frac{1}{4}$  mile on center line of section 8. Thence South west to north line of the south  $\frac{1}{2}$  of south west  $\frac{1}{4}$  of section 8.

~~Thence a line down a certain Canyon on south side for about  $\frac{1}{2}$  mile, Thence down a certain Canyon running a little south west till it strikes the Wild Horse Creek on the Indian Reservation line.~~  
Thence from section line <sup>running</sup> between sections 8 and 9, to follow up on the north side of the south prong Wild Horse Creek in the most practical course to the stake of the North East Corner of Umatilla Indian Reserve, Thence East on section line between sections 10 and 15. as near as practical to the South East Corner of section 10. thence on section line running South for about  $\frac{1}{4}$  mile, till it intersects



the road on the banks of the Umatilla River.  
 all in T. 3 North of Range 36 W. M. Umatilla Co. Oregon  
 Total distance of said new road about 6 miles.

Said Road to be 40 feet wide  
 And your petitioners will ever pray
