Finds that there are no remonstrance or objections on file to the vacating of County Road Nos 15, 74, and 100 in Twp 3 and 4 North Range 35 E. W. M. described particularly as follows:

beginning at a point which point is the center of Section 34,

Township 4 North, Range 35, E. W. M., thence in a Southeasterly

direction for a distance of approximately two and one half miles to a

point where County Road No. 74 crosses the section line between sections

1 and twelve in Township 3 North, Range 35, E. W. M.,.

And it appearing to the Court that the said Road should be vacated for the reasons that it has not been used for some time, is very steep and dangerous to travel, is not necessary to the locallity, and does not justify the burden of maintenance and that the "bublic will be benefited by its vacation.
