RESOLUTION

County Road No. 15, 74 & 100

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be vacated as follows to wit:  
Beginning at the center of Section 34 Township 4 North, Range 35, E.W.M.,  
thence in a southeasterly direction to the northeast corner of the SE $\frac{1}{4}$  of  
the SE $\frac{1}{4}$  of said section 34, known as County Road No. 100; also beginning  
at the northeast corner of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 34, Township 4 North  
Range 35; thence in a southeasterly direction to a point where Road No. 74  
crosses the section line between sections 1 and 12, Twp. 3 North range 35, E.W.M.  
and that said Road or Highway be vacated by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of January 1934, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it be and is hereby declared to be the intention of the said County Court to vacate a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed vacating of a County road as described above

shall commence, run and terminate as follows, to-wit:  
That the legal description of the land adjacent to said roads or part thereof  
and the names of the owners: SE $\frac{1}{4}$  sec. 34, Jos. H. Key; NW $\frac{1}{4}$  SW $\frac{1}{4}$  and W $\frac{1}{2}$  SW $\frac{1}{4}$  SW $\frac{1}{4}$   
NE $\frac{1}{4}$  Sec. 34 R. 35, E. W. M.; SE $\frac{1}{4}$  sec. 34, Jos. H. Key; NW $\frac{1}{4}$  SW $\frac{1}{4}$  and W $\frac{1}{2}$  SW $\frac{1}{4}$  SW $\frac{1}{4}$   
NE $\frac{1}{4}$  Sec. 34 R. 35, E. W. M.; NW $\frac{1}{4}$  Sec. 2, SW $\frac{1}{4}$  NE $\frac{1}{4}$  Sec. 2,  
Sec. 35, all in Twp. 4 North, Range 35, E.W.M.; NW $\frac{1}{4}$  SE $\frac{1}{4}$  south  
NW $\frac{1}{4}$  SE $\frac{1}{4}$  north of Road Sec. 2, Linus Anderson; SE $\frac{1}{4}$  NW $\frac{1}{4}$  Sec 2, NW $\frac{1}{4}$  SE $\frac{1}{4}$  south  
of road, American Natl. Bank; S $\frac{1}{2}$  Sec. 1, all in Twp. 3 North, Range 35,  
E. W. M.

BE IT FURTHER RESOLVED that a public necessity for the vacating of said road or highway is hereby declared to exist for the following reasons to-wit: That the said roads or portion thereof which it is now proposed to vacate is useless as a part of the general road system of Umatilla County, Oregon, in that it is not used or needed by the general public, or those living adjacent to said roads.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular February term for the year 1934, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said road: And that this Resolution be duly entered in the Commissioners Journal.
