Now on this day this matter coming on to be heard, this being the time and term for final decision of the Court upon said matter, and,

It appearing that due and lawful advertisement of the final hearing has been given by the posting of three certified copies of the resolution of this Court declaring its intention to vacate such road, in three public places in the vicinity of said road which is proposed to be vacated and also by posting of a certified copy of such resolution on the bulletin board at the North door of the County Court House, in Pendleton, Oregon, being the place of holding the County Court, and all for at least thirty days before the date set by the court for hearing, and,

It appearing that no objections or demonstrations have been filed against the vacation of said road, and

The Court having duly considered the matter, and being of the opinion that said road is not needed as a part of the general road system of Umatilla County.

IT IS HEREBY ORDERED THAT SAID ROAD be vacated, and the same is hereby vacated.

Now on this day this matter coming on for hearing upon the report of the County Roadmaster filed in this Court on the 6th day of November 1925 upon the proposed vacating on said road, beginning at a point in the center of said County Road No 412, said point being 20 feet south of the Northwest Corner of the Northeast Quarter of the Northeast Quarter of Section 30 Township 4 North Range 35 East, W.M.; thence following the center line of said County Road No. 412 South, 840 feet; thence South $52^{\circ}21'$ East, 903 feet; thence South $40^{\circ}51'$ East, 460 feet; thence South $28^{\circ}21'$ East 547 feet, to a point on the section line between Sections 29 and 30; thence South along said Section line, 323 feet to the quarter section corner common to Sections 29 and 30; thence continuing South along said section line 1316 feet to a point 20' North of the Section Corner common to sections 29, 30, 31 and 32; also that portion of the east and west road, running across the south end of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 29, extending from its intersection with County Road No. 412 easterly to the East bank of Wild Horse Creek, all in Township 4 North, Range 35 East, W.M., said county roads being 40 feet wide, 20 feet on each side of the above described center lines, all in Umatilla County, Oregon, shall be undertaken; that said roads are useless as a part of the general road system, are burdensome and dangerous to maintain and that the people and public will be benefitted by the vacation of those parts of said roads above described.

And the examination and report now having been made and said report being before the Court and the same declaring in substance that said road should be vacated and that it is not advisable to preserve the same for any future public road and is useless and burdensome to maintain and that the public will be benefitted by its vacation and it appearing now that it would be the duty of the Court to set a time and place for hearing on said report of the County Roadmaster and to cause notice of said hearing to be given by advertisement posted at the place of holding the County Court, namely; at the County Court House in Pendleton, Oregon and at three public places in the vicinity of the said

road so sought to be vacated for at least thirty days before the date of hearing on the report of County Roadmaster aforesaid.

IT IS THEREFORE ORDERED that hearing shall be had on said report of the County Roadmaster at the County Court Room at the County Court House, at Pendleton, Oregon at 10 o'clock in the forenoon on January 9th, 1926, and,

IT IS FURTHER ORDERED that the County Clerk of Umatilla County, Oregon prepare and L.J. Shannon, County Road Master is hereby order to post notices of said hearing at the place of holding this court, to-wit: on the bulletin board at the North door of the County Court House at Pendleton, Oregon, and also in three public places in the vicinity of said road or portion of County Road No. 412 sought to be vacated for at least thirty days prior to said 9th day of January, 1926, and that due proof of said advertisement shall be made to this court as by statute provided.
