paid, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land sixty (60) feet wide, being thirty (30) feet on

each side of the center line of said road, as surveyed over and across the N.W. 1/4 Sec 6 and the S.W. 1/4 Sec 6.

of Section 6 Township 3N, Range 36 East W. M.

Beginning at Station 32+45 of the Reed and Hawley Mountain Highway Survey which Station is approximately 320 feet South and 2640 feet East of the 1/4 Corner

between Sections 6, 13N, R36E and Sec 1 Township 3N, Range 35 East W. M.

Thence running in a Westerly direction approximately 3610 feet to Station 68+55 of the said survey, which Station is approximately 1070 feet due South and 0.0 feet

of the 1/4 corner between Sections 6, 13N, R36E and Sec 1 Township 3N,

Range 35 East W. M. Containing 4.28 Acres More or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
