

PETITION FOR VACATION OF COUNTY ROAD

TO THE HONORABLE COUNTY COURT OF UMATILLA COUNTY, OREGON:

We, the undersigned, your petitioners, who are residents and freeholders within Umatilla County, Oregon, owning the real property set opposite our respective names, respectfully petition your honorable body to cause to be vacated a County Road in said County and State, which said road commences, runs and terminates as follows, to-wit:-

Commencing at the quarter-section corner common to Sections 14 and 23 in Township 5 N. R. 34 E. W. M., Umatilla County, Oregon, running thence easterly to the east line of said Section 14; thence meandering northerly to the point of intersection of said road with what is commonly known as the Barrett Grade, near what is commonly known as the Conrad House, which said point is in Section 1 of said Township and Range near the south end of the north and south centerline of said Section 1. Said road to be vacated being commonly known as the "Geer Springs Grade"

Your petitioners further respectfully show that said County Road, or part of County Road, is useless, being practically paralleled by the road known as the "Barrett Grade", that said road is dangerous and burdensome to maintain by reason of the roughness of the country it traverses; that said road is useless as a part of the general road system, and that the public will be benefited by its vacation.

WHEREFORE your petitioners respectfully pray that your honorable body cause said road to be vacated.
