IN THE COUNTY COURT OF THE STATE OF OREGON,
FOR THE COUNTY OF UMATILLA.

In the matter of opening County Road
No 593, petitioned for by M.M.Ewing
et al BEGINNING, at the Southeast cor
Section 22, Tp 6 North Range 34 E.W.M.

Now on this 13th day of July, 1906, comes the report
of the Board of County Road Viewers, heretofore instructed at the May, 1906
term of this Court, to view, layout and report upon said proposed County
Road No 593, COMMENCING, at the Southeast corner of Section 22 Township
6 North Range 34 E.W.M, and run thence due West 4 miles and terminating
at the West line of Township 6 North Range 34 E.W.M. as a County Road
for final hearing, the same having been publicly read on two different
days of the same term of Court, being publicly read the first time on
the 9th day of July 1906 and publicly read the Second time on the 13th
day of July, 1906, and the Board of County Road Viewers having reported
favorably and recommended the opening of said road as hereinafter ordered
opened, as a County Road, and the field notes and plat of Survey, being
on file and certified to by the Surveyor appointed to survey the same,

There is also filed herein a remonstrance to said petition signed
by Frank Dickerson et al. and the Court being satisfied that said road
as is hereinafter Ordered to be opened would be of sufficient public
utility, it is, THEREFORE HEREBY ORDERED, by the Court, that the report
of the Board of County Road Viewers, be approved, and said road shall be
and the same is hereby made, laid out and established along the following
part of the route described in the petition for a road herein filed, as
follows to-wit: Commencing at the Southeast corner of Section 22 Tow-
nship 6 North Range 34 E.W.M, and run thence due West 1-1/2 miles to
the Southwest corner of the Southeast Quarter of Section 21, Tp 6 N.R.34E
And the Court being satisfied that the remainder of said road would not
be of sufficient public utility, the Court declines and refuses to allow
so much of said road as lies between the Southwest corner of the South-
east Quarter of Section 21 Tp 6 North Range 34 E.W.M. and the terminal
point of said proposed road, and particularly described as follows: Com-
mencing at the Southwest corner of the Southeast Quarter of Section 21
Township 6 North Range 34 E.W.M and

run thence West to the Township line of Township 6 North Range 34 E.W.M,
and it is further hereby ordered that the survey, plats and field Notes
be recorded in the record of Plats and Field Notes of Umatilla County,
and that said road be opened as a County Road in accordance with the
report of said Viewers and in accordance with this Order and that the
Road Supervisor through whose District said road runs, be and he is here-
by ordered to open the same for public use.
