in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Two Hundred Seventy Five and no/100 Dollars paid in cash the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: All that part of the property of Louis F. Stewart and Hazel Stewart, his wife, in the West Half of Section 1, T. 4 N. R. 34 E. W.M. included within a strip of land 35 feet wide being 30 feet wide on the east side and 5 feet wide on the west side of the following described center line; Said center line being 55 feet east of and parallel to the center line of the Northern Pacific Railway Company's Branch Line and more particularly described as follows; Begining at a point on the Section line, approximately 830 feet west of the Quarter Section corner common to Sections 1 and 12, thence North 19° 39' West, 1581.6 feet, thence on a curve to the left of radius 5729.6 feet, 1260.0 feet, thence north 32° 15' west approximately 1310 feet to a point on the Section line approximately 880 feet south of the section corner on the Township line common to Sections 1 and 2. All in Township 4 North, Range 34 East W.M. (PROVIDED HOWEVER that it is understood that the right-of-way hereby conveyed shall not be opened until the 15th of March, 1926, unless the grantors herein shall have completed the fencing of such right-of-way prior to said time, in which event such right-of-way shall be opened as soon as such fence is completed.)

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
