has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 35 feet wide, being 5 feet on the west side and 30 feet on the east side of the center line of the road as surveyed over and across the Northwest Quarter of Section 12, Township 4 North, Range 34 East, W.M. Said road center line being 55 feet east of and parallel to the center line of the Northern Pacific Railway Company's Athena Branch line and more particularly described as follows: Beginning at a point on the Quarter Section line, approximately 320 feet North of the Center of Section 12, thence North 19° 39' West, 2469 feet, more or less to a point on the Section line, approximately 830 feet West of the Quarter Section corner common to Sections 1 and 12, All in Township 4 North, Range 34 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
