All that part of the property of Mary L. Stewart and R.E. Stewart, her husband, in the Northeast Quarter of Section 2, T. 4 N. R. 34 E. W.M. within a strip of land 35 feet wide being 30 feet wide on the east side and 5 feet wide on the west side of the following described center line: Said center line being 55 feet east of and parallel to the center line of the Northern Pacific Railway Company's Athena Branch Line and more particularly described as follows; Beginning at a point on the Section line common to Sections 1 and 2, approximately 880 feet south of the Section Corner on the Township line common to said Sections 1 and 2, thence North 32° 15' West, approximately 1066.6 feet to a point on the Township line approximately 570 feet west of the Section corner common to Sections 1 and 2. All in Township 4 North, Range 34 East, W.M.
