

IN THE COUNTY COURT OF THE STATE OF OREGON
FOR UMATILLA COUNTY.

In the Matter of Locating and Establishing a County Road from the Oregon-Washington Highway, near Adams, Oregon, southeasterly up Spring Hollow to the head of Thorn Hollow to connect with County road No 750 at a point near Thorn Hollow Station on the O.W.R. & N Co's. railroad in ~~xxx~~ Tp 3 N. R. 34 E.W.M, Tp 3 N. R. 35 E.W.M and Tp 2 N. R. 35 E.W.M, in Umatilla County, Oregon, same being designated as County Road No 865.

Now on this day this matter coming on to be heard upon the report of the Board of County Road Viewers, heretofore instructed to view and report upon said proposed road, and said report having been public read on two different days of the same term of court, to-wit: having been publicly read the first time on June 2nd 1926 and publicly read the second time on June 7th, 1926, and is now up for final hearing, and the Court finds that no objection or exceptions are on file against said road or report, and said Board of viewers, finds that said road as laid out would be a practicable and necessary one and a benefit to the general public, and recommended that said road be opened and established as a county road of Umatilla County, Oregon.

Said Board further finds that the owners of the land through which said road is to be laid out and established will be rendered less valuable, by reason of its establishment, as follows:

IT IS THEREFORE HEREBY ORDERED that said report of the Board of County Road Viewers, be approved, that said road be established and declared a public highway of Umatilla County, Oregon, and that the

width of said roadway or right of way be a strip of land sixty feet wide, being thirty feet wide on each side of its centerline, excepting through, over and across the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 4 Tp 2 N. R. 35 E.W.M, where the roadway or right of way, shall be a strip of land eighty feet in width, being forty feet on each side of its center line.

It is further ordered that the Clerk of this Court be instructed to draw warrants to pay the necessary expenses of viewing said road and to draw warrant to pay such damages as are herewith awarded by the Board of viewers.
