have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across the South-east Quarter of Section 22, T. 3 N. R. 34 E. W.M. Said center line being more particularly described as follows; Beginning at a point known as Station 159 / 10 of the said highway survey, which point is 2420 feet North and 2640 feet West of the Section corner common to Sections 22, 23, 26 and 27, T. 3 N. R. 34 E. W.M., thence South 25 13' East, 906.0 feet, thence on a 573 foot radius curve to right, 117.5 feet, thence South 13 28' East, 266.5 feet to a point known as Station 172 / 00 of the said survey, which point is 1320 feet North and 2210 feet West of the Section corner common to Sections 22, 23, 26 and 27, Township 3 North, Range 34 East, W.M.
