TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON
FOR UMATILLA COUNTY.

We, the undersigned board of County Road viewers heretofore instructed to view the above mentioned proposed road submit the following report.

Pursuant to your Order, we met at the point of beginning of the above mentioned proposed road on the 18th day of April, 1931, and having qualified as viewers proceeded to view the proposed road,

We find the road as located and laid out to be a feasible and necessary one and a benefit to the public, therefor, we respectfully recommend that it be opened and established as a County road of Umatilla County, Oregon.

We find that Wm Courtney in the SW $\frac{1}{4}$ of Section 3, Twp. 2N, Range 33, E.W.M., is damaged in the amount of \$10.00; this covers the taking of .02 of an acre of land and the damage to his barn yard and other inconvenience that the road may have caused him.

Also Elmer Turner in the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ and SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 3, Twp. 2N, Range 33, E.W.M., is damaged in the amount of \$11.00, which covers the taking of .11 of an acre of land and any other inconvenience which the road may have caused him or damaged his property.

Also that ^{W.W. 167} Pete Schapmawa in the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 3, Twp. 2N, Range 33, E.W.M., is damaged in the amount of \$13.00, which covers the taking of .13 acres of land and any other damage or inconvenience which the road may have caused him or damaged his property.

Also that ^{W.W. 167} Minnie Corneyer in the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 3, Twp. 2N, Range 33, E.W.M., is damaged in the Amount of \$6.00, which covers the taking of .06 acres of land and any other

inconvenience that the road may cause him.

Also that Mm Myrick in the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 3, Twp. 2N, Range 33, E.W.M., is damaged to the amount of \$7.00, which covers the taking of .07 acres of land and any other inconvenience to him or damage to his property.

Other than that which is herein mentioned we find that the property owners, leasers, or renters touched by, adjacent to, or in the vicinity of the above mentioned road are damaged in the amount of nothing.
