Report of Viewers Field notes and Plot of Road running from NE Cor of South East Quarter of Sec 7 T5 NR 33 E to the forks of North Juniper Canyon (Road No 124)

To the State County Court for }
Umatilla County Oregon }

We the undersigned having been appointed by you State body to view out and locate a County Road in the above named County and State would respectfully report that we met at the time and place appointed and after being duly qualified according to law by J M Coffey Deputy Surveyor of Umatilla County we called to our aid J B Davis + A J Lang Chaimmen and Adam Roethrock marker we proceeded to view out and locate said Road commencing at a point at the north East Corner of South East Quarter of Sec 7 T5 NR 33 E thence South half a mile to the NE Corner of Sec 16 T5 NR 33 E thence on a west line to the SW Corner of Sec 12 T5 NR 32 E thence north half a mile thence west until it strikes the Road down North Juniper Canyon thence in a north westerly direction down said Canyon to the forks to intersect road down South Juniper we would further report that we found the Country along line of ^{said} Road very broken and difficult for a good practicable Road from the Commencing point to the SW Corner of Sec 12 T5 NR 32 E the above name portion of Road which is the first five miles and a half require a large amount of labor to make it practicable as a wagon Road the location could be much improved and shortened by running down North Juniper Canyon where the Road first intersects it running west the road down North Juniper Canyon a a good practicable location for said Road and is much needed and could be easily kept in repair we therefore would recommend the granting of said petition on the ground of the pressing need of said Road

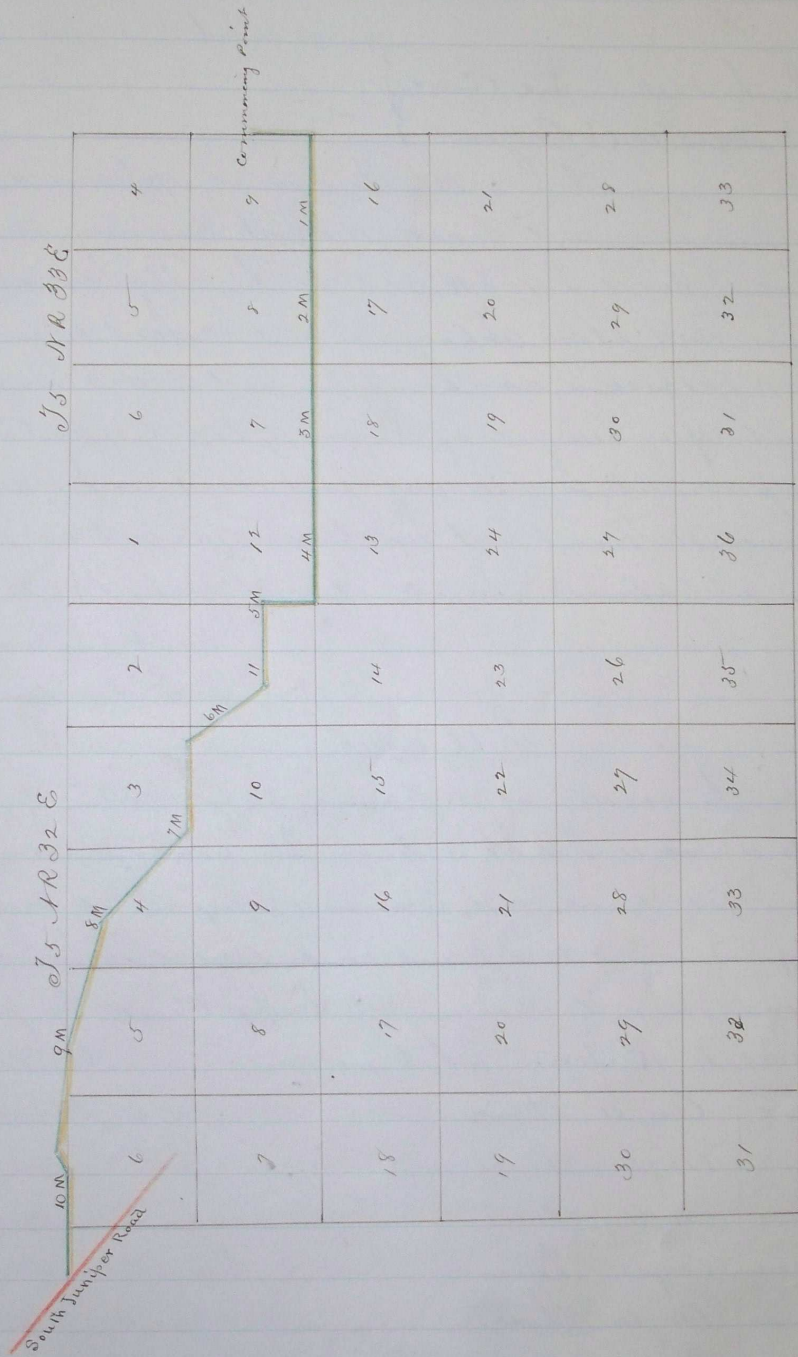
