has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point 105 feet south and 22 feet east of the north east corner of the North West 1/4 of section 1, Twp. 4 North, Range 33, E.W.M.; thence around an 8° C. R. for a distance of 217.4 feet to a point in the present county right of way which point is 187 feet west and 20 feet south of the south east corner of the South West 1/4 of section 36, Twp. 5 North, Range 33, E.W.M.

Also a strip of land 10 feet wide described as follows by meets and bounds beginning at a point 187 feet west and 20 feet south of the south west corner of the South East 1/4 of Section 36, Twp. 5 North, Range 33, E.W.M.; thence east along the present county right of way for a distance of 5090 feet; thence south 10 feet; thence west 5090 feet; thence north 10 feet to the point of beginning.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
