20 feet north of the section corner common to sections 5, 6, 7, and 8, Twp. 4 North, Range 34 E.W.M.; thence along a tangent with an approximate bearing of North 29° 40' West a distance of 1215 feet to a point 1015 feet north and 20 feet east of the above described corner, same township and range, containing 1.67 acres more or less, this being a strip of land 60 feet wide over and across the above described property.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

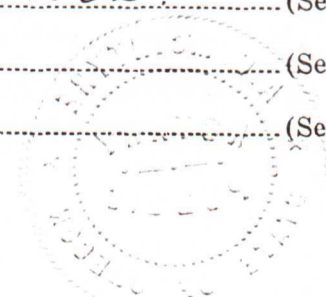
