RESOLUTION

County Road No. 898.....

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed From German Hall to a point on the section line 800 feet West of the quarter section corner common to sections 28 and 33 Township 4, North Range 33, E. W.M.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of Feb. 1930, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road No. 898

shall commence, run and terminate as follows, to-wit:

Beginning at a point on the Pendleton Cold Springs Highway 1730 feet North and 1260 feet West of the center of section 21, Township 4 North Range 32 E. W.M.; thence running in an easterly direction following the German Hall Myrick Market Road survey to a point on the section line 800 feet West of the quarter section corner common to sections 28 and 33 Township 4 North, Range 33, East, W.M.

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet on each side

of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: that it is a part of the special district to improve said road.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular March term for the year 1930, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon, on the 22<sup>nd</sup> day of March, at 10 o'clock A.M.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by County Roadmaster as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road. And that this Resolution be duly entered in the Commissioners Journal.
