Beginning at a point on the South line of the above described parcel, said point being 95 feet east of the center of Section 10, Twp. 4 N. R. 32, E.W.M. and bearing in a North Easterly direction as shown on the survey to a point on the north line of said parcel of land, said point being 800 feet west of the section corner common to sections 2, 3, 11 and 12, Twp. 4N, Range 32, E.W.M., and containing 4.49 acres more or less.
