

Petition for County Road

To the Honorable County Court of Wmatilla County State of Oregon.

We the undersigned householders of Wmatilla County State of Oregon residing in the vicinity of the herein proposed road; hereby petition your Honorable body at your next regular session to be held in April A. D. 1888 to lay out a county road beginning near the head of Greasewood gulch running up said Greasewood and down Vansycle Canyon to the intersection of the road running from the the state line to Clear Springs
Said road further described as follows, to wit:

Beginning at a point 20 rods east of the S. W. cor of the N. W. $\frac{1}{4}$ of sec 27 T. 5 N. R. 33 E. W. N. being also the terminus of road No. 249 thence running northerly up Greasewood gulch to the summit on the most practicable route through the N. W. $\frac{1}{4}$ of sec 27 the S. W. $\frac{1}{4}$ of sec 22 the S. E. $\frac{1}{4}$ of sec 21 thence northerly down a small

gulch on the most practicable
route; through the S E $\frac{1}{4}$ of sec 21
to a point 20 rods and 10 feet west
of the N. E. cor of the S E $\frac{1}{4}$
of sec 21 thence northwesterly & back
to a point 6 rods & 11 ft westerly from
the south end of a ditch fence
on the N E $\frac{1}{4}$ of sec 21; thence
northerly to a point on the line
between sections 16 & 21; said point
being 31 rods 14 ft westerly from the
S E corner of sec 16; thence northerly
79 rods through the E $\frac{1}{2}$ of sec 16
to a point 19 rods and 5 ft southwest
from the S. W. cor of the School
house; thence 25 rods northeasterly
to a point 126 feet northwesterly
from the N. W. cor of the school house
thence northwesterly parallel with
the rail road 128 rods thence
northeasterly 6 rods across the
railroad track, thence northwesterly
on the most practicable route
to the line between sections 16 & 9
to a point 6 rods from the centre
of the main railroad track thence
northwesterly down Vansycle canyon
on the most practicable route
through the S. E. the S W $\frac{1}{4}$ & the
N W $\frac{1}{4}$ of section 9. to a point
intersecting the road from the
state line to Bear springs. All the

above numbered land being in
township 5 north range 33 E. N. 14.
