In the matter of viewing, surveying and laying out  
County Road No 447

To the Honorable County Court of the State of Oregon  
for Umatilla County

We, the undersigned, the viewers heretofore appointed to view,  
and locate road No 447, submit the following report:

Pursuant to an order of the Honorable Court we  
met John W Kimberell, Surveyor, at Helix, on Decem-  
ber the 22<sup>d</sup>, 1894, and were by him each duly sworn to  
faithfully and impartially discharge the duties of our ap-  
pointments

We called to our aid A D Cooley } Chairman  
Geary Kimball }

who were by the surveyor each duly sworn. We viewed,  
surveyed and located said road No 447, as specified in our  
order, and find the same to be most practicable, and would most  
respectfully recommend it be declared and established a public high-  
way.

Note - I met the viewers, John Loepinger and J B Kennedy at  
Helix, Or, on the 7th day of Dec. 1894, as per order of the County  
Court, but George Gibson, one of the viewers, being absent, we ad-  
journed and met again from time to time, notifying him each  
time, viz: on the 12th, 17th and Dec 22<sup>d</sup>, 1894, at which latter date  
all the viewers being present, we proceeded to view, survey and  
locate said road No 447, as by law required


