Commencing at the N.E. corner of Sec 13, in T. 3. N. R. 28 E. W. 7 M. set post 4 feet long, 4 ins square 20 inches in the ground. Marked R. dug pits and made mound of earth 18 inches high 3 feet at base. thence I run South 80° chains set post 4 feet long, 4 inches square. Marked 1 M. thence west, 80° chains set post 4 feet long, 4 inches square. Marked 2 M. thence west, 34 25 chains intersect Road No. 172, runs North East and Southwest. set post 4 feet long 4 inches square. Marked R. T dug pits and made mound, 18 inches high 3 feet wide at base.
